




Ten Commandments

Common Law Principles



- 2. Don't exalt anything you created above all else in your life.
- 3. Don't make rash promises or oaths you won't keep and don't wish anyone misfortune or harm.
- Don't work 7 days a week, your body and mind needs rest.
- 5. Be respectful to your parents and other people.
- 6. Don't intentionally harm or murder anyone.
- 7. Don't break your promise to your spouse, family members or associates, including marriage vows.
- Don't take anything that is not yours.
- 9. Don't lie.
- 10. Don't obsess about what someone else owns or has a relationship with to the point you would violate any of the above rules to obtain it or destroy it.

Basically, treat everyone how you want to be treated and finish everything you promised to do as long it doesn't break any of the above rules.



Executive, Judicial, and Legislative are fighting for *Power*, while "All The People" have no *authority* and are given privileges that can be taken away on a whim.

"We THE People" have all the *authority* from which we delegate small portions to the four branches to conduct the business of "We The People".

Definitions of Important words we use



· Power

 An *authority* enabling a man or woman to dispose of an interest vested either in himself / herself or in another man or woman. In the case of the de facto government, brute force.

Authority

Lawfull or rightful power; a right to command or to act; authority exercised by a man or woman by virtue of his / her office or trust; dominion; jurisdiction; authorization; as, the authority of a prince over subjects, and of parents over children; the authority of a court.

Duty

 That which one owes to another; that which one is bound, by any natural, moral or (legal) Lawfull obligation, to pay, do or perform; obedience; submission

Obligation

The binding power of a vow, promise, oath or contract, or of law, civil, political or moral, independent of a promise; that which constitutes legal or moral duty, and which renders one liable to coercion and punishment for neglecting it.




